In order for your child to receive a funded 2-year-old place, you need to be in receipt of one or more of the following:

- Income support
- Income-based Jobseeker’s Allowance (JSA)
- Income-related Employment Support Allowance (ESA)
- The Guarantee Credit element of State Pension Credit
- Support through part VI of the Immigration and Asylum Act
- Support from the Local Authority Social Services Asylum team (SSAT)
- Child Tax Credit and/or working Tax credit and have an annual income under £16,190
- Working Tax Credit 4 week run on (the payment you get when you stop qualifying for Working Tax Credit)
- Universal tax Credit

Or

- They are looked after by a local Council.
- Your child has an Education, Health and Care Plan.
- Your child gets Disability Living Allowance.
- Your child has left care under a Special guardianship order, child arrangements order, residence order or adoption order.

You will need to provide a letter that clearly states the benefits you are in receipt of and which clearly states your current address.
